# **Key Role**

To teach A-Level Economics and to act as a tutor to a group of A level students

### **Main Duties and Responsibilities**

In addition to the duties laid down in the Sixth Form College Conditions of Service, the post holder will:

- 1. Teach Economics to A-Level
- 2. Act as a personal tutor to a group of A level students and participate in the Centre's pastoral system
- 3. Take part & organise enrichment activities such as trips and visits
- 4. Take part in departmental meetings, INSET and continuous professional development
- 5. Contribute to curriculum planning in A Level Economics
- 6. Monitor students' progress and contribute to the evaluation of results in A Level Economics
- 7. Maintain a safe working environment during teaching sessions

#### **Expectations of the Post Holder**

- 1. To demonstrate model behaviours that, at all times, are consistent with an open, inclusive and participative style.
- To be proactive in identifying and pursuing opportunities that are appropriate to maintaining his/her professional development, and actively participate in the Group's appraisal scheme.





- 3. To carry our his/her duties at all times with due regard to the Group's policies, including Safeguarding, Health & Safety, Equal Opportunities, and Data Protection, and participate in training as and when required.
- 4. To work flexibly and to undertake such other duties that may reasonably allocated by the line manager.

# **Special Conditions**

- 1. The nature of this post means that the post holder may need to travel from time to time to other College centres and external venues.
- 2. The post holder will be contracted to work for a defined number of hours per week but it is a requirement of this post that the holder will flex these hours to reasonably meet the needs of the service, which may include working occasional evening and weekends.
