# Job Description and Person Specification



Post: Logistics Lecturer

Contract: Hourly Paid

Hours: Variable

Reporting to: Head of Logistics

**Salary**: £24,71 – £26,78 per hour (basic pay – holidays excluded)

## **Key Purpose:**

This role involves delivering Logistics and Supply chain based short courses to a range of learners, accurately completing course paperwork and conducting progress reviews when required. The post holder must maintain robust CPD to ensure the delivery of training is supported by current working knowledge of legislation pertaining to the logistics and supply chain industries. Management training at or around level 3 will also be delivered as part of the suite of courses. Of key importance is the ability to give clear and accurate feedback and set realistic milestones for learners and give additional support where required.

## Main Duties and Responsibilities:

#### **Teaching and Assessment**

- To teach the classes listed in your Contract(s).
- · To prepare schemes of work and lesson plans
- To contribute learning materials and assignments to the collective learning resources of the College.
- To undertake detailed assessment, and maintain attendance, destination and other records as required.
- To participate in the College's quality assurance procedures as directed.
- To contribute to the action planning of students and provide interim and end of year reports as requested.
- To participate in team meetings and staff training and development as required.

## Other Duties and Responsibilities

- To participate in subject and course team meetings and reviews, for which additional payment may be made at a non-contract rate of pay.
- To ensure the requirements of external agencies such as examination and validation bodies are met.

### **Expectations of the Post Holder:**

- 1. Ensure that the College policy for equality and diversity of opportunity is adhered to and promoted in all aspects of the post holder's work

All tutorial staff at the College are expected to support students to develop their English and Maths skills, using teaching, learning and assessment opportunities within the curriculum or through the delivery of Additional Learning Support, to do so. You will be expected to mark students' work carefully and thoroughly, giving advice on how it could be improved, and also correcting spelling, grammar and vocabulary when necessary.

All teaching staff at the College are expected to support students to develop their English and Maths skills, using teaching, learning and assessment opportunities within the curriculum or through the delivery of Additional Learning Support, to do so. Newly appointed staff without a Level 2 English and Maths qualification will be supported with inservice training to develop their professional skills to enable them to confidently develop the English and Maths skills of their students.
